NOTICE, WRITTEN ACKNOWLEDGMENT, AND HOLD HARMLESS AGREEMENT COMES NOW, **GLENRIDGE GOLF CLUB** a South Dakota Corporation, (hereinafter referred to as the Club) by and through its Board of Directors and duly authorized officer, and the undersigned member of said corporation (hereinafter referred to as Member), and agree as follows:

1. The Club has rented to the Member a space to store his/her golf clubs and motorized golf cart.
2. The Member hereby specifically acknowledges that he/she is responsible to purchase liability insurance regarding the use, operation and ownership of said motorized golf cart.
3. The Member hereby specifically agrees to indemnify and hold harmless the Club for any and all damages, causes of action, claims, demands, or other requests for pecuniary damages arising from the Member's use, operation, or storage of the Member's motorized golf cart on the Club's premises.
4. The Member further acknowledges that he/she is fully responsible for the use and operation for the motorized golf cart either by himself/herself or any individual that he/she should permit or suffer to use the motorized golf cart.
5. The Member specifically acknowledges that the Club has no obligation to provide liability insurance relating to said motorized golf cart.
6. The Club hereby provides written notice to the Member that the Club's insurance policy specifically excludes from the insurance coverage the Member's private property stored upon the Club's premises.
